VOORSPELDE TEELWAARDES (VTW'S)

Teeltwaardes vir ramme in hierdie katalogus is uit 'n nasionale rasantleding verkry. Hierdie tussen-kudde evaluering maak teeltwaardes van alle diere vergelykbaar.

INTERPRETASIE EN TOEPASSING:

As voorbeeld, kan ons die VTW veseldikte van 2 ramme neem. Indien ram A 'n negatiewe VTW van -1.5 mikron het en ram B ook 'n negatiewe VTW van -0.3 is die relatiewe genetiese verskil -1.2 mikron. Die veseldikte van ram A se nageslag sal onder gelyke omstandighede waarskynlik $-1.2 \div 2 = 0.6$ mikron fyner wees as dié van ram B. (Ons deel die totaal deur 2 aangesien die ram en die ooi elkeen slegs 50% van hulle gene aan die nageslag oordra).

VTW's toon verskille tussen diere in absolute waardes aan nl. kg of mikron (Veseldikte). Speengewig VTW's word aangedui as speen direk (individu se direkte genetiese meriete om vinnig te groei tot op 100 dae ouderdom) en speen maternaal (die gedeelte van elke individu se meriete op 100 dae ouderdom wat toegeskryf word aan die genetiese vermoë van die dier se moeder). Speen direk en speen maternale VTW's word in 'n verhouding van 1 : 2 ingesluit in die seleksie indeks om die **Algemene Meriete (AM)** van elke dier te bepaal. AM weerspieël die **groei vermoë** van Dohne Merino's tot op 100 dae ouderdom soos gebalanseer met wolproduksie en wolkwaliteit (veseldikte).

Die teeltwaarde vir reproduksie word onafhanklik van algemene meriete aangedui as getal lammers gespeen per ooi gelam. Hierdie teeltwaarde word bereken deur alle lammers per ooi leeftyd in ag te neem. Dit word dus uitgedruk as die persentasie verandering wat per ooileeftyd verwag kan word (byvoorbeeld + 1.431 persent lammers meer speen per ooi gelam per ooileeftyd).

Basisjaar:

Die basisjaar vir teeltwaarde vergelykings verskuif elke jaar sodat VTW vergelykings in verhouding bly tot tot die huidige populasie geregistreerde Dohne Merinos. Let op dat VTWs dinamies is en verander namate produksie-inligting oor verwante diere vermeerder. Die algemene meriete (AM) van diere verander dus voortdurend en raak meer akkuraat en betroubaar.

ESTIMATED BREEDING VALUES (EBV's)

Breeding values for rams in this catalogue were obtained from a national breed analysis. The result of this across flock comparison is that EBV's of all animals in this catalogue can be compared.

INTERPRETATION AND APPLICATION

Take for example the EBV of the fibre diameter for two rams. **If ram A has a negative EBV of -1.5 micron and ram B also a negative EBV of -0.3, the relative genetic difference will be -1.2 micron. Under similar circumstances the progeny of ram A will in all probability be $-1.2 \div 2 = 0.6$ micron finer than that of ram B.** (We halve the result because rams and ewes each contribute only half the genes to their progeny).

EBV's express differences between animals in absolute terms viz. Kg. or micron (fibre diameter). Weaning weight EBV's are expressed as Weaning direct (the individual's own ability to grow up to 100 days of age) and weaning maternal (the portion of each individual's merit at 100 days of age ascribed to the genetic mothering ability of the specific individual's dam). Weaning direct and weaning maternal EBV's are included into the selection index, in a ratio of 1 : 2 in order to estimate the **General Merit (GM)** of each animal. GM reflect the Dohne Merino's ability to grow fast up to 100 days of age as balanced against wool production and wool quality (fibre diameter).

Breeding values for reproduction are expressed in terms of numbers of lambs weaned per ewe lambs, independently from general merit. These breeding values are calculated by taking into account all lambs weaned per ewe lifetime. It is therefore expressed as the percentage change per ewe lifetime to be expected. For example +1.431 percent lambs weaned per ewe which lambed per ewe lifetime.

Symbol	Relative importance in population	Expected prediction:
*	Top 10% of trait	Very good chance that animal will change this trait in your flock.
+	Top 40% of trait	Above average. Possibility that this animal will change this trait in your flock.
=	Between bottom 40% and top 40% of trait	Average: Possibility that this animal will effect little change in this trait in your flock.
-	Bottom 40% of trait	Below average: It is possible that this animal will change the trait (probably deteriorate) in your flock.
x	Bottom 10% of this trait	Far below average: Very good chance that this animal will change the trait (probably deteriorate)in your flock.

BWT = Body Weight / **CFW** = Clean Fleece Weight / **FD** = Fibre Diameter
Mat/Lamb = number of matings and lambs produced by dam

Base year:

The base year for breeding value comparisons shifts every year to facilitate comparison of EBV's to the current alive population of Dohne Merinos. Note also that EBVs are dynamic and change, depending on the accumulation of production data measured on related animals. General Merit of animals therefore change continuously and becomes more accurate and reliable with time.

RULES OF AUCTION

(As Auction House hereinafter referred to as the "Auctioneer" and the person conducting the auction referred to as the "auctioneer")

1. The Sale by auction is subject to a reserve price, unless specifically stated to the contrary by the auctioneer.
2. The seller (owner) and/or his agent and the auctioneer may bid up to the reserve price of the owner (seller), but shall not be entitled to make a bid equal to or exceeding the reserve price.
3. This Rules Of Auction comply with Section 45 of the Act and the Regulations of the Act and Section 45 of the Consumer Protection Act, Act 68 of 2008 ("the Act") read as follows:

"Auctions:

45. (1) In this section, "auction" includes a sale in execution of or pursuant to a court order, to the extent that the order contemplates that the sale is to be conducted by an auctioneer.
- (2) When goods are put up for sale by auction in lots, each lot is, unless there is evidence to the contrary, regarded to be the subject of a separate transaction.
- (3) A sale by auction is complete when the auctioneer announces its completion by the fall of the hammer, or in any other customary manner, and until that announcement is made, a bid may be retracted.
- (4) Notice must be given in advance that a sale by auction is subject to –
 - (a) a reserve or upset price; or
 - (b) a right to bid by or on behalf of the owner or auctioneer, in which case the owner or auctioneer, or any other person on behalf of the owner or auctioneer, as the case may be, may bid at the auction.
- (5) Unless notice is given in advance that a sale by auction is subject to a right to bid by or on behalf of the owner or auctioneer –
 - (a) the owner or auctioneer must not bid or employ any person to bid at the sale;
 - (b) the auctioneer must not knowingly accept any bid from a person contemplated in paragraph (a); and
 - (c) the consumer may approach a court to declare the transaction fraudulent, if this subsection has been violated.
- (6) The Minister may prescribe requirements to be complied with by an auctioneer, or different categories of auctioneer, in respect of –
 - (a) the conduct of an auction;
 - (b) the records to be maintained with respect to property placed for auction; and
 - (c) the sale of any property by auction.
4. The auctioneer will during the auction announce the reason for the auction unless the reason is the normal and voluntary disposal by the owner.
5. The auction will commence at the published time and will not be delayed to allow any specific person or more persons to take part in the auction.
6. All goods and livestock (hereinafter referred to as the "assets") are sold by the Auctioneer as agent on behalf of the Seller, who hereby authorizes the Auctioneer to collect the purchase price from the Buyer and the seller do hereby cedes to the Auctioneer all the seller's rights, title and interest in and to its claim for payment of the purchase price against the purchaser which session the Auctioneer do hereby accepts.

17. In the event of any dispute the Buyer shall only have a claim against the Seller and not against the Auctioneer.
18. The Seller warrants as against the Auctioneer that the assets are free of patent and latent defects and that any right or claim ceded to the Auctioneer in terms of these Rules Of Auction is free of any defect or right of deduction or set-off, and that the said right or claim is fully and immediately enforceable against the Buyer.
19. The Buyer shall, prior to the sale, ascertain whether there are any defects in the assets and any bid by a Buyer shall be considered as acceptance of the assets with any patent or latent defects in their condition at the time of sale.
20. The Buyer shall not be entitled to withhold payment of the purchase price to the Auctioneer as a result of any possible or pending claim that he may have against the Seller on the grounds of misrepresentation or for any other reason whatsoever.
21. The purchase price is payable by the Buyer to the Auctioneer in cash (to the discretion of the Auctioneer) or by bank-guaranteed cheque on the date of sale ("the payment date") unless other payment terms and or means are agreed between the Auctioneer and the Buyer. The Company reserves the right to refuse any method or means as payment.
22. In the event that the Auctioneer agrees to facilitate the purchase of the assets by paying an amount equal to the purchase price to the Seller before the Buyer makes payment to the Auctioneer ("the Payment Terms Agreement"), then the following shall apply:

- 22.1 The election to make any payment to the Seller shall be in the sole and absolute discretion of the Auctioneer, which discretion may be exercised separately in regard to each transaction entered into by the Buyer.
- 22.2 Upon payment of the amount referred to in 10.1 above the Seller's right, title and interest in and to any claims and other rights as against the Buyer in terms of or connected with the sale of the assets shall forthwith be ceded and transferred to the Company which session the Auctioneer hereby accepts.
23. In the event of any Payment Terms Agreement between the Auctioneer and the Buyer, the following shall apply;
 - 23.1 No Payment Terms Agreement shall be valid unless reduced to writing and duly signed on behalf of the Auctioneer. The facilitation of any sale by the Auctioneer as referred to in this paragraph 10 shall be strictly subject to the terms and conditions of the Payment Terms Agreement.
 - 23.2 In the event of any conflict between the contents of this document and the Payment Terms Agreement, the provisions of the Payment Terms Agreement shall prevail.
 - 23.3 No application for credit as defined in section 8 of the National Credit Act, Act 34 of 2005, will be received or considered by the Auctioneer.
24. Anyone that intends to bid at the auction (Buyer) must register his or her identity on the bidder's record prior to the commencement of the auction and such registration must meet the requirements of the FICA (Financial Intelligence Centre Act, 2001) in respect of the establishment and verification of identity of the person and the person must sign the registration entry and the prospective Buyer must furnish the Auctioneer with a copy of his/her identity document and proof of residence.
25. 26. A person who attends the auction, to bid and to sign the bidder's record, on behalf of another person (i.e. on behalf of a company or legal entity) must produce a signed letter of authority that expressly authorizes him or her to bid or sign the bidder's record on behalf of that person. Where a person is bidding on behalf of another entity the letter of authority must appear on the letterhead of the entity and must be accompanied by a certified copy of the resolution, if required, authorizing him or her to bid on behalf of the entity. The person bidding on behalf of or signing any document on behalf of the Buyer pursuant to a successful bid thereby binds himself personally as co-principal debtor with the Buyer for payment of the purchase price and personally guarantees all the obligations of the Buyer under these Rules Of Auction.
27. In the event where a Buyer allows another person to purchase on his or her buyers number, the registered Buyer shall be liable for payment of such purchases. 28. Until all amounts owing by the Buyer have been paid in full, the Buyer hereby:

29. The Buyer and the Seller hereby consent to the jurisdiction of the Magistrate's Court in terms of Section 45 of the Act on Magistrate Court (Act 32 of 1944 as amended) for any action instituted by the Auctioneer against the Buyer although the Auctioneer is entitled to institute proceedings in any competent Court.
30. A certificate issued by a Manager of the Auctioneer, whose appointment and authority shall not be necessary to prove, shall be *prima facie* proof of the amount owing by the Buyer to the Seller or the Auctioneer.
31. Any indulgence granted by the Auctioneer to the Buyer or the Seller will not prejudice the rights of the Auctioneer in terms of these Rules Of Auction and such indulgence will not constitute an amendment or waiver or novation of these Rules Of Auction.
32. The entries made in the Company's auction roll shall be *prima facie* evidence of the transaction and shall be binding on the Seller and the Buyer.
33. The bidder's record and the vendor or vendu roll will be made available for inspection within reasonable time after the auction at the office of the Auctioneer during normal business hours free of charge.
34. The Auctioneer does have a trust account into which all money will be paid for the benefit of the Seller.
35. 42. In the event of the sale requiring the consent of any statutory authority or any court of law, then this auction will be subject to the granting of such consent.
43. The Buyer and the Seller do hereby consent to the payment of Attorney- and own client costs in the event of any legal action being instituted against them by the Auctioneer or Company.
44. Any agreement contrary to these Rules Of Auction shall not be binding unless it is confirmed in writing and signed by a Manager of the Auctioneer.
45. If any clause or term of these Rules Of Auction should be invalid, unenforceable and illegal, then the remaining terms and provisions of these Rules Of Auction shall be deemed to be severable there from and shall continue in full force and effect unless such invalidity, unenforceable or illegality goes to the root of these Rules Of Auction.
46. The Company reserves the right to amend these Rules Of Auction in writing.
47. By entering a bid any prospective Buyer binds himself or herself to this Rules Of Auction.
