- 4) VAT must be paid, where applicable.
- 5) a. Payment: Electronic transfer on the day of the sale
  - b. Buyers will be refunded for any short deliveries on the truck of catalogue sale animals, the capital amount plus trust account interest.
- 6) <u>CATALOGUE ANIMALS</u>: In all instances the Sellers responsibility for losses ceases when the animals are loaded onto the contractors vehicle. **Buyers are advised to make use of transit insurance**.
- 7) The Principal has determined the sexes and info as well as possible, but Vleissentraal does not guarantee the absolute correctness of it.
- 8) Animals comprised out of family groups and will be of different age groups, but there will be no more males than females in a group, unless otherwise stipulated.
- 9) Vleissentraal for it's part guarantees nothing. Make sure you are happy with what you are bidding on.
- 10) All instructions have to be given in writing to the sale's clerk at the sale.
- 11) Arrange transport directly at the game capturer's desk.
- 12) Before bidding make sure from the Department of Environmental Affairs that your property qualifies for the game that you intend to buy. No permits will be issued if the requirements are not met. Buyers of listed TOPS species must beforehand be in possession of TOPS permit / Exemption permit / WR reg. certificate. All purchased animals have to be paid for today, even if a permit is refused by Environmental Affairs.
- 13) BEFORE opening the doors of the truck to unload the animals, count the animals aboard the truck in the presence of the truck driver.
- 14) Animals will be delivered only if the buyer has paid for them in full and has met all his financial obligations relevant to his purchases. Any arrangements made by the purchaser for the transport of game as per par.11, are subject to the conditions set out in this paragraph.
- 15) Kindly complete a route sketch, from **each reserve** to your destination of offloading. (blank documents available at sales clerk)
- 16) Permit fees payable to Department of Environmental Affairs.



- The Sale by auction is subject to a reserve price, unless specifically stated to the contrary by the auctioneer.


