MEBALA YA RONA – 1 APRIL 2022

We are selling on behalf of the Sellers

- A. Vleissentraal's standard conditions of sale (Rules Of Auction) apply.
- B. You are buying per lot.
- C. A bid once made cannot be withdrawn after the fall of the hammer.
- D. VAT must be paid, where applicable.
- E. Payment: Electronic transfer on the day of the sale
- F. The Principal has determined the sexes and info as well as possible, but Vleissentraal does not guarantee the absolute correctness of it.
- G. Vleissentraal for it's part guarantees nothing. Make sure you are happy with what you are bidding on.
- H. Permit fees payable to the different authorities.
- I. All arrangements in respect of Accommodation and Permit / Administration fees is the responsibility of the buyer. Please check at each lot for the info and arrange directly with the persons involved.

J. CULLING PACKAGES:

Buyers must arrange culling dates directly with the Reserve Managers.

Packages will be auctioned @ a R / cc per kg price.

Culling operation must be in compliance with the MEAT SAFETY ACT 40 of 2000, a certified GAME MEAT EXAMINER must be on site to examine the carcass.

Bidders must also submit proof of a SERVICE LEVEL AGREEMENT with a registered Game meat abattoir.

Registration for culling will be allowed if the above conditions are satisfied.

The culling actions involved with the take-off of this package / lot will take place under the strict supervision of Mebala Ya Rona and North West Parks Board representatives who will ensure that the following conditions are adhered to at all times. No exception to these conditions will be considered and any deviation, whether negligent or wilful, from the conditions by the buyer of the package, or any of their personnel, may result in the culling actions being suspended or terminated and any monies paid to the auctioneer as deposit being forfeited.

1. All prospective buyers of **culling packages** must have a **valid membership with Game SA** and proof of such membership must be presented when registering to take part in the culling package auction.

2. The successful buyer may only make use of the services of a professional harvesting team with a valid **PCOASA** (Professional Culling Operators Association of South Africa) registration and proof of such registration must be presented to the Mebala Ya Rona and North West Parks Board representative before the culling operation can commence.
3. **All animals will be culled during the day from a helicopter only;** no exception to or deviation from this condition will be considered under any circumstances whatsoever. The buyer is entirely responsible for providing the helicopter at their own cost. The helicopter pilot must have a valid commercial game and cull rating license and present it before operation will commence.
4. The buyer of the culling package is entirely responsible for all of the actions associated therewith and must therefore provide all personnel, including the culling team, skinners, cleaners, etc. and all equipment required for the cull, such as suitable recovery vehicles, slaughtering frames, scales, transport vehicles, etc. Mebala Ya Rona and North West Parks Board will only provide oversight and will not be involved in the cull in any other manner whatsoever.
5. No culling package may be divided into smaller packages by the buyer for resale to a third party. Bidding will be per package on the day of the auction.
6. **A fixed deposit for the package / lot as indicated and is payable to the auctioneer at closing of the auction** and the successful buyer receives confirmation of the amount payable. The remaining amount must be paid immediately after the carcasses are weighed and loaded. Prospective buyers bid per kilogram on the lot and pay a fixed deposit on the day of the auction. The reason for this is simply that the weight of each carcass can only be determined once it is culled (obviously not prior to such).

The deposits payable for each lot has been set as follows;

Zebra culling (25 animals) each Lot:

Deposit R25 000 (Twenty five Thousand Rand)

Blesbok Culling (250 animals) each Lot:

Deposit R30 000 (Thirty Thousand Rand)

Black wildebeest culling (500 animals) each Lot:

Deposit R100 000 (One Hundred Thousand Rand)

7. The weighing of each carcass will be done under the supervision of both a representative of Mebala Ya Rona or North West Parks Board and the buyer.
8. **Full payment of all loaded and weighed carcasses must be made before departure of each load from the nature reserve to the auctioneer. The deposit will be deducted from the final load from the Reserve. Overpayment will be refunded by the auctioneer.**

9. Carcasses will be weighed as follows;
Blesbok and Black Wildebeest: head, feet and viscera removed and with the skin on;
Burchell Zebra: viscera removed and with the skin on,
However, the buyer may stipulate that the head remain on the carcass, but the carcass will be weighed as such and payment will be made in accordance with such weight. No deductions from the total weight of the carcass will be made and no negotiations in terms thereof will be entered into.
10. Buyers must make their own arrangements for accommodation with the nature reserve and payment for accommodation must be done with the reserve on arrival.
11. **All culling lots must be taken off during August 2022.**
12. The date reserved for the culling package / lot will be negotiated between both a representative of Mebala Ya Rona or North West Parks Board and the buyer and may not be postponed or changed unless agreed to by all parties. The package together with any monies already paid will be forfeited in full if such cull does not take place during the period stipulated as a result of any actions by the buyer that may prohibit such.
13. Buyers need to provide a suitable container or holder for intestines / stomachs if they wish to retain these. No intestines / stomach may be loaded onto any vehicle carrying meat carcasses if not placed in a closed plastic container. Buyers need to inform a representative of Mebala Ya Rona or North West Parks Board if intestines / stomach and head are not to be taken that suitable arrangements can be made for removal.
14. The buyers for the culling package / lot must ensure that animals of both genders are included in the cull unless stipulated otherwise in the catalogue. The buyer must also ensure that at least 20% of young animals are included in the cull; in other words, the culled package / lot may not comprise of adult bulls only, cows and young animals must be included. The gender composition and make-up of each of the culling packages / lots will be discussed in detail with the buyer prior to the commencement of the cull by representative of Mebala Ya Rona and North West Parks Board.
15. All carcasses must be loaded and transported from the reserve with skins on. No skinning of any carcass at any time will be permitted on the reserve.

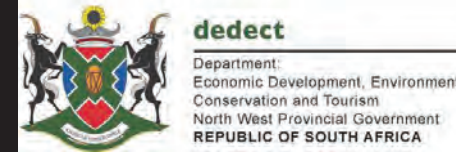

 - A person who attend the auction, to bid and to sign the bidder's record, on behalf of another person (i.e. on behalf of a company, close corporation or trust) must furnish the Auctioneer with a written signed Power of Attorney, prior to the commencement of the Auction, that expressly authorizes him/her to bid/sign the bidder's record on behalf of that legal person, failing which he/she will be personally liable for payment of any purchases made by him/her. Where a person in bidding/signing on behalf of a legal person, the Power of Attorney must appear on the letterhead of the legal person and must be accompanied by a certified copy of the resolution, if required, authorizing him/her to bid/sign on behalf of the legal person. The person bidding on behalf of or signing any document on behalf of the buyer, in terms of the Power of Attorney, pursuant to a successful bid, hereby binds himself/herself personally as co-principal debtor with the buyer for payment of the purchase price and personally guarantees all the obligations of the Buyer under these *Rules Of Auction***
 - In the event where a Buyer allows another person to purchase on his or her buyer's number, the registered Buyer shall be liable for payment of such purchases. No bid by an unregistered Buyer will be accepted by the auctioneer and the Buyer will have no claim to any of the assets allegedly purchased by him.
 - Until all amounts owing by the Buyer have been paid in full, the Buyer hereby:
30.1 irrevocably undertakes to identify the purchased assets in such a manner that he can at any time identify and indicate the assets deemed to be the property of, and pledged to, the Auctioneer.
30.2 grants the Auctioneer at all reasonable time's access to the premises where the assets are stored or kept for the purposes of perfecting its pledge and exercising any other rights in terms of these *Rules Of Auction*.
 - The Buyer and the Seller hereby consent to the jurisdiction of the Magistrate's Court in terms of Section 45 of the Act on Magistrate Court (Act 32 of 1944 as amended) for any action instituted by the Auctioneer against the Buyer although the Auctioneer is entitled to institute proceedings in any competent Court.
 - A certificate issued by a Director of the Auctioneer, whose appointment and authority shall not be necessary to prove, shall be prima facie proof of the amount owing by the Buyer to the Seller or the Auctioneer.
 - Any indulgence granted by the Auctioneer to the Buyer or the Seller or non-compliance by the Auctioneer of this Rules will not prejudice the rights of the Auctioneer in terms of this *Rules Of Auction* and such indulgence will not constitute an amendment or waiver or novation of this *Rules Of Auction*.
 - The entries made in the Auctioneer's auction roll shall be prima facie evidence of the transaction and shall be binding on the Seller and the Buyer.
 - The bidder's record and the vendor or vendu roll will be made available for inspection within reasonable time after the auction at the office of the Auctioneer during normal business hours free of charge.
 - The Auctioneer does have a trust account into which all money will be paid for the benefit of the Seller minus the agreed commission.

 - The Buyer and the Seller do hereby consent to the payment of attorney and own client costs in the event of any action being instituted against them by the Auctioneer whether summons or any other legal action is instituted or not.
 - Any agreement contrary to these *Rules Of Auction* shall not be binding unless it is confirmed in writing and signed by a Director of the Auctioneer.
 - If any clause or term of these *Rules Of Auction* should be invalid, unenforceable and illegal, then the remaining terms and provisions of these *Rules Of Auction* shall be deemed to be severable there from and shall continue in full force and effect unless such invalidity, unenforceable or illegality goes to the root of these *Rules Of Auction*.
 - Default by Buyer:** Should the Buyer/Purchaser refuse or otherwise fail to pay the purchase price within 7 days of the due date, the Auctioneer shall be entitled to:
48.1 claim interest from the Buyer/Purchaser at the prescribed mora interest rate calculated from the date of purchase to date of payment, and/or
48.2 repossess the assets, to resell same at the risk of the defaulting Buyer/Purchaser who shall be liable for all costs in connection with the resale and any loss or damage incurred, and will not be entitled to any profit that may arise from the resale, and/or
48.3 institute legal proceedings for the payment of any amount owing or for the return of the assets in which event the provisions of clause 48.2 will apply,
48.4 recover the Auctioneer's legal costs calculated at the Attorney and own Client tariff as well as collection, tracing, storage and transport costs, and
48.5 retain in pledge any assets or other property in the possession of the Auctioneer belonging to either the Buyer/Purchaser or the Seller as security for the due fulfilment of any obligation owed to the relevant party or the Auctioneer.
 - The Company reserves the right to amend these *Rules Of Auction* in writing.
